What socialism did and didn't do for women is a topic still widely discussed and debated in scholarly literature as well as in the broader public sphere. We still know very little about what women in general, but even less about what women from marginalised background thought about the socialist women's emancipation processes. This workshop aims at exploring the knowledge accumulated by scholars from fields beyond intellectual history, especially social history, anthropology, literary studies about women from marginalised contexts during state socialism in Eastern and Central Europe, and beyond. The talks focus on Romani women, women in Soviet Central Asia, and Muslim women in Bosnia and Hercegovina, and the broader Yugoslav region.
